

## 2025 CROOK COUNTY FARM BUREAU FEDERATION SCHOLARSHIP APPLICATION

## **QUALIFICATIONS:**

- A resident of Crook County and a graduating senior from an accredited Crook County high school, home school or virtual school, or have a certificate of high school graduation/diploma OR
- A resident of Crook County and a student at a college, vocational program, or other training.
- Applicant or applicant's parent/guardian MUST have a current regular membership in their name with Crook County Farm Bureau Federation, paid up by March 1, of current year.
- Must have a minimum 3.0 GPA based on a 4.0 scale.

## **HOW TO APPLY:**

- 1. DEADLINE: The application packet MUST be received by March 30, 2025, 11:59 pm.
- 2. A complete application packet MUST include:
  - > The current year 2 page scholarship application. (Do not add pages to expand on questions) > A current academic transcript (most recent semester).
  - > Two (2) current letters of recommendation dated and signed (not older than 12 months)
