### **Legislative Review:**

During the 2025 Wyoming Legislature, the Wyoming Farm Bureau Federation (WyFB) represented member policy including, but not limited to, property tax relief, eminent domain, predator control, foreign land ownership and water rights. This review offers a glimpse of the legislation WyFB worked that passed the 2025 session. The review also offers a look at “How they Voted” on a few specific bills. # Property Taxes

---

- HB 39 Property Tax Refund Programs-Revisions.....SUPPORT**  
Lowers the percentage of median gross household income to qualify for property tax refund from 165% to 145%.
- SF 69 Homeowner Property Tax Exemption.....SUPPORT**  
Exempts 25% of the property taxes on a single-family residential structure and associated land, up to \$1 million market value starting with the 2025 tax year.
- HB 279 Property Tax Exemptions-Order of Application.....MONITOR**  
Outlines that if more than one tax exemption applies to the same property, the exemption shall be applied in the manner determined by the Department of Revenue.
- SF 81 Tax Exemption-Property Owned by the State.....SUPPORT**  
Exempts state agricultural lands leased for grazing purposes from property taxes with a repeal date of December 31, 2026.

# Taxes

---

- SF 48 Business Property Exemption.....SUPPORT**  
Exempts \$75,000 of personal property from taxation if used for business purposes.
- SF 49 Tangible Personal Property-Index and Depreciation .....SUPPORT**  
Provides that personal property used for business would be valued by index and depreciation rather than market value.

# Education

---

- HJR 3 Support for Rural Schools.....SUPPORT**  
This resolution would emphasize that the state legislature supports free elementary education for rural school children.



# State and Public Lands

---

- HB 61 State Land Lease Amendments.....SUPPORT**  
Allows persons not currently in violation of state land leasing provisions a preference in securing state land leases.
- SF 63 State Lands-Fencing 2.....SUPPORT**  
Allows an adjacent landowner to build a fence bordering state land. The state or current lessee would be obligated to pay for one-half of the fence.

# Animal Health and Identification

---

- HB 90 Anthrax Outbreak Protocol.....SUPPORT**  
Directs the Wyoming Livestock Board to develop a protocol to notify the appropriate entities of a confirmed non-negative Anthrax case.
- HB 275 Treatment of Animals.....MONITOR**  
Provides offenses for knowingly causing suffering, torturing, or mutilating an animal and clarifies that the first offense of animal cruelty will be a misdemeanor and anytime beyond the first is a felony.
- HB 92 Wyoming Livestock Board-Memorandum of Understanding.....SUPPORT**  
Instructs the Wyoming Livestock Board to solicit MOUs with surrounding states to allow non-electronic types of animal ID.
- SF 64 Wyoming Opposes Mandatory Electronic ID Devices-Livestock.....SUPPORT**  
Outlines that Wyoming is opposed to mandatory electronic livestock ID and can and will use traditional methods of identifying livestock.

# Private Property Rights

---

- SF 6 Residential Property-Removal of Unlawful Occupant.....SUPPORT**  
Allows a property owner to remove a person illegally on private property and to collect any associated damages.
- SF 181 Eminent Domain-Energy Collection Systems-2.....SUPPORT**  
Prohibits the use of eminent domain unless 66% of the land or 66% of the landowners have easement agreements.

# Government/ Elections

---

- HB 133 Sanctuary Cities, Counties, and State-Prohibition.....SUPPORT**  
Prohibits implementation of sanctuary policies by cities, counties, and the state.
- HB 156 Proof of Voter Residency-Registration Qualifications.....SUPPORT**  
Outlines that a person must show they have been a Wyoming resident for 30 days prior to voting in an election.
- HB 165 Ranked Choice Voting-Prohibition.....SUPPORT**  
Prohibits ranked choice voting in Wyoming.
- HB 69 Foreign Adversary Ownership or Control of Business Entities.....SUPPORT**  
Prohibits a country deemed by the federal government to be a foreign adversary from owning or controlling a business in Wyoming.
- SF 191 State Funds-Proxy Voting and Pecuniary Investments.....SUPPORT**  
Directs the investment of state funds with firms on a financial basis that do not have environmental, social, governance, political or ideological interests. Ideological interests include those that have crippled, corrupted, disadvantaged, subverted, damaged or otherwise harmed the citizens, children, industry and financial well-being of Wyoming and America.

# Energy and Communications

---

- HB 192 Public Utilities-Wildfire Mitigation and Liability Limits.....SUPPORT**  
Requires public utilities file a wildfire mitigation plan with the state. Substantial compliance with the plan lessens liability for electrical companies in the event of a wildfire.
- SF 51 Wyoming Telecommunications Act Revisions.....SUPPORT**  
An update of the Wyoming Telecommunications Act, which includes the universal service fund. This fund works to equalize basic telephone service fees, regardless of the location of the service.
- SF 154 Industrial, Wind and Solar Projects-Hearing Deadline.....SUPPORT**  
Extends from 60 days to 90 days for hearings dealing with industrial, wind, and solar projects in front of county commissioners and from 45 days to 60 days for the decision by the county commissioners.
- SJR 4 Resolution on Commercial Base Load Power Generation.....SUPPORT**  
This resolution would request the Governor of Wyoming concentrate on promoting stable dispatchable base load power resources.
- SF 132 Protecting Critical Infrastructure and Systems from Drones.....SUPPORT**  
Outlaws operating unauthorized drones over critical infrastructure.

# Water/Wildlife/Natural Resources

---

- HB 117 Omnibus Water Bill-Construction.....MONITOR**  
Annual bill allocating funding for construction of water projects.
- SF 43 Temporary Water Use Agreements Amendments.....SUPPORT**  
Temporary water uses changes would be allowed for up to five years at a time, for a total of 10 years. The bill was amended in committee to make sure all other users affected by the change will be held whole.
- SF 80 Abandonment of Water Rights-Limitations.....SUPPORT**  
Outlines that water rights not used because of repairs or replacement of infrastructure would not be subject to abandonment.
- SF 82 Omnibus Water Bill-Planning.....MONITOR**  
This is the annual water project planning bill utilizing water development funding.
- HB 211 Hunting Wildlife From Vehicles.....MONITOR**  
Prohibits using vehicles to pursue wildlife requiring a license or permit to harvest, or animals on the threatened or endangered list.
- SF 88 2025 Large Project Funding .....MONITOR**  
Annual request for funding for large projects using Wyoming Wildlife and Natural Resources Act.
- SF 179 Sage Grouse Mitigation-Amendments.....SUPPORT**  
Allows for mitigation credits if a landowner performed conservation measures in a service area.

# Ag Marketing/Agri-tourism

---

- SF 84 Country of Origin Label-USA Beef.....SUPPORT**  
Establishes country of origin labeling for beef that is from cattle born, raised, slaughtered, and processed in the USA.
- SF 120 Wyoming PRIME Act.....SUPPORT**  
Allows a producer to market meat processed in a custom slaughter facility which is not state or federally inspected. This meat would have to be labeled that it was processed in a non-inspected facility and would not be allowed to be sold or given away by the person who originally purchased the meat. This bill would not be in effect until it is legal under federal law.
- SF 108 Recreation Safety-Agritourism.....SUPPORT**  
Adds agritourism to the Recreation Safety Act, which would limit liability for those in agritourism.

# How They Voted

---

This section includes some Senate files and House bills that were chosen at random by the Wyoming Farm Bureau Federation policy team, to show how both the Senate and the House voted on specific legislation. At the top of each section, you will find either a SF (Senate File) or HB (House Bill) and then a number. After the number you will find the “Catch Title” of the file or bill selected. You can search the bills by the number, navigate to the bill, and click on the “Votes” tab. This will show the votes on the bill (both in the house and senate) as it progressed through legislation. You will notice some say “passed” versus “adopted”. Passed means the bill/file was approved by both chambers of legislature. Adopted means the legislation was referred to a joint conference committee (JCC) and the JCC recommendations were adopted by both chambers.
